# CHAPTER FIVE REED J. NEUBERGER and KING FAROUK

#### Part 1 — DEE JAY NELSON IS REED J. NEUBERGER

Reed J. Neuberger is purported to be Nelson's business manager. The booklet, THE JOSEPH SMITH PAPYRI, that was written by Dee Jay Nelson and published by Modern Microfilm Co., Salt Lake City, Utah, 1968, has an introduction written by Reed Neuberger:

There are several obvious errors in the foregoing introduction — errors that should, at least, be obvious to a man who purports to know Nelson well:

The first sentence refers to "Professor" Nelson. This man "Neuberger" has known Nelson since 1953 and should know that he does not hold any legitimate degree and has not been a Professor anywhere.

"Neuberger" states that Nelson has delivered lectures in French. Nelson does not know French! His transcripts show no foreign language taken in either High School or College (see p. 41, 43), and he does not list France in his resumes or press releases as a country he studied in (see Appendix, pp. 209-218). Was this inserted to impress the reader?

"Neuberger" says he has "Often walked in on the family breakfast to hear the conversation being carried on in ancient Egyptian or Coptic." Very interesting! The night of the Feb. 22, 1980, lecture by Dee Jay Nelson, this author talked to Mrs. Nelson personally and she said her husband was the scholar — that she didn't understand a word of Ancient Egyptian languages. If she doesn't understand them, who does he converse with at breakfast? His pet canary? Also, Ancient Egyptian and Coptic are not "conversation" languages.

The first mention of "Neuberger" was in Jerald and Sandra Tanner's book, MORMONISM: SHADOW OR REALITY, p. 307, 317. Because "Neuberger" is mentioned in the Tanner's book, this author asked them if they could give me his address so that I could correspond with him. I received the following hand-written letter from Jerald Tanner and he enclosed a letter that "Neuberger" supposedly wrote to Pres. N. Eldon Tanner, General Authority of the LDS (Mormon) church (see Jerald Tanner's letter on the next page).

This letterhead uses Dee Jay Nelson's home address! Compare this letterhead with Nelson's address in the phone book on page 59.

Nelson is not, and never has been, a professor.

None of the church members, or Bishops, contacted in Billings have ever heard of "Neuberger". On the letter, to the right of the letterhead, the return address is given as Billings — where is he?

It is this author's hope that his "extensive following" will read this book and find out the **truth** about him!

If that were true, why is Nelson unknown to the real professional Egyptologists? Why is he not listed in WHO'S WHO IN AMERICA or some similar publication?

Nelson is not an educated man he doesn't speak several languages.

Nelson claims that these films were shown on the ABC network. ABC in New York has never heard of the films or Nelson!

After this book is read, this author feels that this voice will no longer be loud, but henceforth silent.

Nelson claims no knowledge of Hebrew and certainly is not an authority on the Dead Sea Scrolls.

It would have been interesting to have been able to check the signature against Dee Jay Nelson's!

#### IN SUMMARY . . .

Now that you have read the information written by "Reed J. Neuberger", and the author's comments, it should cause you to wonder how a business manager could know so little about his client, especially since he has been an associate and good friend since 1953. Did it occur to you that "Neuberger" might be Nelson?

The "Neuberger" letter was unsigned — so the signature could not be checked. The letterhead uses Dee Jay Nelson's home address! (Note Nelson's address in the phone book on p. 59.) The Cross Index (city directory) for Billings was checked in the Billings library for every year from 1967 - 1980. Looking under the address of 719 Highland Park Drive, we could find no reference to "Neuberger" — only Dee Jay Nelson! The name "Reed J. Neuberger" does not appear at any address! "Reed J. Neuberger" does not exist! It is this author's belief that Dee Jay Nelson is "Neuberger" If you read the letter carefully it sounds exactly like Nelson.

Why would Nelson go to such lengths? He was obviously trying to "set up" the church so he could go on making a living with his subtle craftiness and deception. President Tanner recalls no such correspondence. It is, therefore, doubtful that this letter was ever sent. In this author's opinion, it was strictly for "show and tell" purposes.

#### PART 2 — DEE JAY NELSON CLAIMS GIFTS AND EMPLOYMENT FROM KING FAROUK

King Farouk was the last Monarch of Egypt. On July 23, 1952, he escaped into exile in Alexandria, leaving behind his impressive collection of Egyptian Antiquities.

Nelson is proud to proclaim that he was once employed by King Farouk and because of his fame and discoveries, he was presented with some Egyptian antiquities as gifts.

The introduction by "Reed J. Neuberger" to Dee Jay Nelson's booklet, THE JOSEPH SMITH PAPYRI, is shown below. Among other interesting comments, "Neuberger" states:

"His discoveries inspired King Farouk to present him with a small collection of Egyptian antiquities which he has added to over the years."

## About The Author

I have been asked to write a brief introduction to the author, my good friend, Dee Jay Nelson. The only dif-ficulty with this assignment is the word "brief,"

In 1953 I retired from retirement (and boredom) to an exciting life as business manager for this remarkable man. When I arise each morning I wonder what country he will be in that night. So far he has visited 72 of them and most of these several times. It is thus hardly surprising that he is a member of the Los Angeles Adventurers Club and past president of the Explorer's League.

Among his personal friends are numbered two kings, two prime ministers, three ex-presidents, bishops, roy-alty and movie stars. One time while we were visiting Amman, Jordan, I jokingly asked why he didn't have dinner with King Hussein. Two nights later he was sitting before

a braised duck in the palace.

He undertakes fantastic projects and it is almost a foregone conclusion that he will succeed. For instance, to better acquaint himself with the history of the New Testament he decided to walk every foot of ground that is known to have been walked by Christ. The magnitude of this project can only be partly understood when one appreciates the complications presented by hostile Middle Eastern frontiers. The task was carried to a successful conclusion more than a year later. To reach some of the Holy Places which are now in Moslem hands and forbidden to Christians he traveled for many months disguised as a Bedouin sheik. He was the first Christian to enter the tomb of Jethro, father-in-law of Moses. He did it during the Festival of Nabi-Shuaib on April 15, 1957, in the midst of twenty thousand Moslem pilgrims. He later became history's fourth Christian to enter the

Mosque of Hebron, built over the Cave of Machpelah, tomb of the Patriarchs. He accomplished these incredible feats with the aid of his good friend Sheik Audah Uba Mo-Amar, chief of the Azazma Bedoudins, walnut-oil-stained skin, brown contact lenses and one simple Arabic phrase learned to perfection......
"Don't bother me. I'm a pilgrim and I'm in contemplation." The amazing thing is that he managed to make motion pictures of these events by concealing an electric camera in a gourd water bottle.

Dee Jay's research in Egyptology began more than twenty years ago when he was discharged from the U., S. Submarine Service. After making a superficial study of ancient languages in the States he decided to add some dimension to his scant knowledge, so he traveled as a stoker in the black bunkers of a freighter to Egypt where he attached himself to the fallahin crew of Hussein Ibrahim, excavation foreman working under Zakaria Goneim, at Memphis. The late Zakaria Goneim was for many years keeper of antiquities at the Necropolis of Saqqara. Dee Jay studied three forms of the ancient language under this famous Egyptian Egyptologist. More advanced knowledge of ancient languages and history were acquired under the tutelage of the late Father Vespo Eliad, Abbot of the Monastery which clings precariously to the side of the Mt. of Temptation, Jordan. His studies have taken him several times to Europe and six times to the Middle East where he has conferred with experts in the Vatican Library, museums and at excavation sites. His distoveries inspired King Farouk to present him with a small collection of Egyptian antiquities which he has added to over the years.

In 1958 Prime Minister David Ben-Gurion (whom Dee Jay calls Dave Green, his real name) invited Prof. Nelson to come to Israel and make the first motion pictures of the Dead Sea Scrolls for television. The two episode show which resulted was seen by capacity audiences in the Pasadena Playhouse and by more than 11,000,000 Americans on the Seven League Boots TV series. After ten years they are still being seen by television viewers in Europe and Australia, Well over 50,000,000 people have now seen them. He has

produced and filmed 39 network television films on natural history and archaeological subjects.

In the introduction to his lecture, p. 184, Nelson submitted this information to Jim Robertson:

"He (Nelson) owns the third largest collection of ancient Egyptian antiquities in the United States, many of which were gifts from King Farouk. Dr. Nelson worked for Farouk doing Egyptian translations and setting up Farouk's library."

Within about thirty days after Dee Jay Nelson lectured in Mesa, this author had accumulated over one hundred pages of material investigating Nelson's credentials. Delos Ellsworth, a friend at Brigham Young University who travels to Egypt often, was asked to take the report to Egypt with him and have it examined by the authorities there. He took it to the Cairo Museum, and there it was seen by Dr. Arthur Wallace, Ph.D., of UCLA, who also often travels to Egypt. Dr. Wallace knew Dr. Hanny M. El Zeini, who lives in Cairo and is an amateur Egyptologist. Dr. El Zeini knows the native Egyptologists personally, and those connected with the Cairo Museum. Dr. El Zeini was kind enough to read my report, and then inquire of his Egyptologist friends about Dee Jay Nelson and his achievements. His letter commenting on the report begins on the next page. You are sure to find this letter most interesting! Among other things, Dr. El Zeini says that it was a Reverend Father Etienne Drioton, a well-known Egyptologist, who catalogued (set up) King Farouk's library — not Nelson, And, as usual, Dr. El Zeini reports, "I have inquired from all the veteran Egyptologists who were working in the Antiquities Department in Egypt about the identity of Mr. D. J. Nelson. No one seems to remember his name . . . "

Some Comments On The Documents Concerning The Truth About Dee Jay Nelson (Handled To Me by Dr. Arthur Wallace

I have carefully studied all the Xerox copies of articles, letters and different statements concerning this subject. In my comments I will just confine myself with the facts that I have been able to check with some witnesses whose integrity and professional honesty are beyond any shadow of doubt.

- I) I have inquired from all the veteran Egyptologists who were working in the Antiquities Department in Egypt about the identity of Mr.D.J.Nelson. No one seems to remember this name or to recollect having seen him participate in any known excavation.
- 2) Dr.Z.Ghoneim was essentially a field-manager and a brilliant excavator. He was not known as a philologist and even less as a "teacher" of hieroglyphs. It is most unlikely that he could have wasted any time on teaching hieroglyphs to Mr.D.J.Nelson.
- 3) The assistants of the late Dr.Z.Ghomeim do not remember hatering seen or heard of Mr.Dr.J.Relson. They also testified that the team working under Dr.Ghoeim was 100 % Egyptian with no foreign assistance at all.
- 4) It is a well-established fact that the late King Farouk was an astute collector. It is quite impossible to think that he would consult a free-lance Egyptologist or confide to him his voluminous collection when he could have at hand the expert advise of the top notch Egyptologists of the time who came to Egypt regularly practically every winter.
- 5) Old officials of the Antiquities department knew that Reverend Father Etienne
  Drioton, a well known Egyptologist, and during the reign of the late King Farouk, he was
  the director-general of the Antiquities Department, was the person in charge of checking
  and cataloguing Farouk's collection. As a matter of fact he was the only person questioned
  about the collection of antiques found in a secret cache in the Abdine Palace in the heart
  of Cairo after the Revolution of the 23rd of July 1952. The committee in charge of verifying and checking the royal possessions in this palace had to resort to the testimony
  of Father E.Drioton in connection with the Antiques collection of Egyptian origin hidden
  in the Abdine Palace.
- 6) At the time of the uprising of the Egyptian Army in the early hours of the morning of the 23rd of July 1952, King Farouk was in Alexandria. He left Egypt, for good, from the Ras-El-Tin Palace. It is practically impossible that the late King Farouk could have been able to take any thing from his impressive Egyptian Antiques collection with him on his departure. The collection was found complete and untouched in the Abdine Palace in Cairo.

- It is evidently impossible that King Farouk could have given any antique pieces as a present to Mr.Nelson. Mr.Nelson could have bought small antique articles from authorised antique shops such as scarabs, amulets etc... but definitely no sarcophagus whose source is evidently questionable.
- 8) The Antiquities Department has never loaned antiques to individuals for demonstration outside Egypt . What ever came out of authorised excavations and digs was divided between the Department and foreign missions of Egyptologists by mutual agreement. Duplicates were the subject of such a division but never rare or unique pieces.
- 9) Enormous amounts of papyri have been smuggled out of Egypt; most are to be found in all of the European museums as well as American institutes and collectors. Joseph Smith could have bought some papyri. It is important to verify and make sure that all those papyri were and that none has been lost.
- 10) The number of lectures said to be given by Mr.Nelson is quite a prodigous and enviable figure.9223 lectures in 32 years on Egyptology, a serious and complicated science, is entirely out of question-even the most popularised lectures. The numerous other activities of Mr. Nelson cannot possibly give him enough time for even 10 % of this astronomic figure.

If I could be allowed to finish these comments on a rather personal note I would say the following:

As an Egyptian Muslim I find the teachings and doctrines of the Mormons both clean, healthy and of high moral values. There is nothing in them that could be considered alien to the teachings of the World's three principal religions; Judaism, Christianity and Islam. All three more closely connected and inter-woven than is generally believed.

I would also add that Mormon doctrines command both respect and esteem .

Having said that much, I believe it is not right to judge the late Joseph Smith now that he has died with his secrets and cannot defend himself in the present controversy.

#### IN SUMMARY . . .

Dr. El Zeini read the report and then compiled the facts from men of integrity and professional honesty who are all veteran Egyptologists working in the Antiquities Department. It is interesting to note that none of the professionals had ever heard of Dee Jay Nelson who claims to be the #1 Egyptologist in the world. Dr. El Zeini, paragraph #9, states that it is important to verify that all of the papyri have been found. It is noteworthy that all the papyri belonging to Joseph Smith have not been found.

In paragraph #10, Dr. El Zeini is of the same opinion as all those who have read this report — that Nelson could not have given all the lectures he claims, written all the books and scientific articles he claims, filmed all the motion pictures he claims, etc. Check his Press Release Information on page 208. It's incredible! There just simply is not enough time in his lifetime to do that. But, since Nelson did none of those things, he wouldn't be aware of the time involved, would he!
